4. The bids will be opened in the presence of Bidders' representatives who choose to attend at in the last date of submission at 13:00 hours at the office of Sunkoshi Rural Municipality, Sindhuli.

Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format as mentioned which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the cash security, the cash to be deposited in **Deposit Account No. 1480100303000002** and submit receipt of deposited amount.
